Electronic Prior Authorization Is Here!

If you haven't already noticed, we are live with the Surescripts Electronic Prior Authorization solution for all of our members. Electronic Prior Authorization allows providers to identify the need for prior authorization during the e-prescribing process and process the prior authorization electronically before sending the prescription to the pharmacy. This significantly decreases your administrative burden and improves patient satisfaction.

<u>Continuous Glucose Monitors (CGM)</u>: CGM is a covered benefit for Medicaid members ONLY if medically necessary. All requests for CGM need to be submitted to our Medical UM department. *Any requests submitted through the Pharmacy PA process will be denied and need to be resubmitted to our Medical UM team.*

<u>Viscosupplements (Medicaid)</u>: Effective 4/1/19, viscosupplements are only supplied as Buy and Bill (submitted as J-codes on medical claims) and ALL require PA. Claims on the pharmacy benefit will be denied.

<u>Opioid Abuse:</u> Care1st is committed to helping our members with opioid abuse. All forms of naloxone are available on our formulary. We encourage prescribers to prescribe naloxone for any member with daily MME >50, especially if the member is on concomitant benzodiazepines, sleep agents or other respiratory depressant drugs; or if member also has respiratory diseases such as COPD or asthma or sleep apnea.

<u>Drug Utilization Review (DUR):</u> Retrospective claim review analysis identified a number of Care 1st members that may be at an increased risk of sudden cardiac death based on the 2011/2012 FDA dosing alert for citalopram. Please consider reviewing your patients on citalopram to ensure:

- Dose of citalogram should not exceed 40 mg/day OR
- Dose should not exceed 20mg/day if the patient is greater than 60 years of age
- Risk of sudden death increases if the member is on other QT prolonging medications.

Pharmacy Quality Measures: ADHERENCE....ADHERENCE

The basis for many of our Quality measures for our Medicaid and Medicare patients begins with taking prescribed medications as directed. Consider discussing adherence with your patients to understand how they are taking their medication and identify any potential barriers to adherence such as: cost, side effects, understanding of disease & importance of prescription therapy etc.

Care1st/WellCare offers many options to help with adherence for Medicaid and Medicare including:

- Scriptsync aligns prescription pick up to one time/month (3+ chronic medications) AND
- Multi-dose packaging (all medications in a specific time of day packet) at no additional cost (5+ medications).
- 90 day fills for Medicare members ONLY
